### Processing of personal data

The Immigration and Naturalisation Service (IND) processes personal data during the assessment of your application, notification or request. This means that, if needed, the IND requests data from you yourself and from other organisations or persons. The IND also uses and stores data and passes it on to other organisations. In doing so, the IND complies with the rules laid down in privacy legislation. For instance, the IND must deal with data safely and with due care. The law also gives rights.
