With this form, you apply for admission and residence in the Netherlands on grounds of re-entry. You can only use this form if you are a foreign national staying outside the Netherlands. You can submit the application yourself if you are 12 years or older. If you want to submit an application for your minor child, you must have parental authority over your child. You submit the application to the Dutch embassy or consulate in the country of origin or the country of continuous residence.* Please check the contact page of www.netherlandsworldwide.nl to find out whether and how you can make an appointment for this.

* *In case there is no Dutch consulate or embassy in your country of origin or permanent residence, please turn to the nearest Dutch representation.*

Appointment at the Dutch embassy or consulate

Please take this application form, your passport photo and valid passport with you to the appointment at the Dutch embassy or consulate. The embassy or consulate employee will register your application and fill out the information box above. You will also receive a confirmation letter with your registration number (V-number). Please keep this letter: you will need it later. After submitting the application to the embassy or consulate, you will receive this application form back.

If you give your consent to communication by e-mail (see section '7 Declaration of consent'), the embassy or consulate employee will provide you with a file password. This password will be written in the box at the top of this page. It is very important that you keep your password safe and it is strongly recommended that you keep a copy of this application form for your records.

After the appointment

To be able to assess your application, the Immigration and Naturalisation Service (IND) in the Netherlands needs information from you. Please complete and send this form, with all the necessary documents mentioned in section '5 Means of evidence', to the IND within three weeks from the date of your application (see the date above). Please also enclose the confirmation letter you received from the embassy or consulate. If you do not send all the necessary documents, the assessment of your application will be delayed. If the IND does not receive the information and documents in time, your application will be rejected.

4 Declaration of intent to undergo a TB test

In order to obtain a residence permit, you must be prepared to undergo a tuberculosis (TB) test in the Netherlands and - if necessary - treatment. If you are granted a residence permit, you will actually have to undergo a TB test within three months after having received your residence permit.

When you are in the Netherlands, you should make a TB test appointment with the Municipal Health Service (GGD) in the area where you live or will be living (for further information visit the website www.ggd.nl).

Should it become clear after the issue of a residence permit that - despite signing the declaration of intent - you failed to undergo a TB test within the period of three months, this may result in a cancellation of the permit that was granted.

Please note! The obligation to undergo the test does not apply if you are a national of one of the countries listed in the appendix '[Exemption from the obligation to undergo a tuberculosis \(TB\) test](#)'.

- I hereby declare that I am prepared to cooperate in a tuberculosis test and any treatment. I am aware of the fact that I must undergo a TB test within three months after the residence permit has been received. If I fail to do so, this might have consequences for my right of residence in the Netherlands.

5 Means of evidence

Requirements of foreign means of evidence

Documents must be in Dutch, English, French or German. In case the documents are drafted in another language, you need to have these translated by an authorised translator. Send a copy of the original documents together with a copy of the translation.

You are former Dutch national. You were born and raised in the Netherlands as a Dutchman (362)

Please enclose the following evidence with your application:

- a copy of your birth certificate;
- a '[Antecedents certificate](#)' appendix that you have fully completed and signed (only if you are 12 years of age or older); and
- means of evidence and details relating to the duration and the nature of your previous stay in the Netherlands.

☐ You are a former Dutch national and above the age of majority. You live in another country other than the country of which you are a citizen and you have special connections with the Netherlands (363)

Please enclose the following means of evidence with your application:

- a [‘Antecedents certificate’ appendix](#) that you have fully completed and signed;
- means of evidence showing the duration and the nature of your previous stay in the Netherlands;
- means of evidence showing that you:
 - followed at least half of your primary education in the Netherlands, the Caribbean Netherlands, Curaçao, St. Maarten or Aruba;
 - you followed a study programme as a minor that was predominantly based on the Netherlands; or
 - you have gained close ties with the Netherlands through other circumstances, such as upbringing, social position and/or employment.

☐ You are a minor. You have accommodation and legal representation in the Netherlands and you have resided legally (or as Dutch citizen) in the Netherlands for 10 years (365)

Please enclose the following means of evidence with your application:

- a [‘Antecedents certificate’ appendix](#) that you have fully completed and signed (only if you are 12 years of age or older);
- means of evidence showing that you have accommodation and legal representation in the Netherlands;
- means of evidence showing the duration and the nature of your previous residence in the Netherlands.

☐ You are eligible for repatriation on grounds of article 8 of the Repatriation Act (315)

Before leaving the Netherlands you resided for at least 3 years in the Netherlands with a residence permit and you are returning within one year of your departure. The period of 3 years does not apply to your minor child. The minor child must have had a valid residence permit and you must have returned to the Netherlands at the same time. You must also submit your application for a residence permit at the same time. This period also does not apply to a child that was a minor at the time of repatriation, but who has reached the age of majority since then and who returns to the Netherlands within one year of departure and then applies for a regular residence permit.

Please enclose with the application:

- a [‘Antecedents certificate’ appendix](#) that you have fully completed and signed (only if you are 12 years of age or older);
- a copy of the decision from the Social Insurance Bank, in which the right to the basic provisions or the repatriation provisions has been granted and in which the date of departure is specified.

☐ You are a minor. You have accommodation and legal representation in the Netherlands and you have resided legally (or as Dutch citizen) in the Netherlands for 5 years before submitting your application. The Netherlands is the most obviously designated country for you (365)

Please enclose the following means of evidence with your application:

- a [‘Antecedents certificate’ appendix](#) that you have fully completed and signed (only if you are 12 years of age or older);
- means of evidence showing that you have accommodation and legal representation in the Netherlands;
- means of evidence showing the duration and the nature of your previous residence in the Netherlands;
- Please note! The Netherlands is the most obviously designated country for you if your connections with the Netherlands are stronger than with your country of origin. In order to assess that, the IND will look at the following factors:
 - the reasons for repatriation;
 - the duration of the residence in the Netherlands and the country of origin;
 - the schooling that you followed in the Netherlands and abroad;
 - the work experience that you gained in the Netherlands and abroad;
 - your knowledge of the Dutch language;
 - the presence of any family members of yours in the Netherlands; and
 - previous attempts to return to the Netherlands.

You must submit as many details as possible about these points together with your application.

6 Payment of fees

Before your application can be assessed, you must pay a fee. The fee for an application for admission and residence in the Netherlands on grounds of re-entry, submitted on or after 1 January 2024, is € 228, with the exception of one type of application (see below). The application is free of charge for citizens of San Marino and Israel.

Exception

The application for admission and residence in the Netherlands on grounds of article 8 of the Repatriation Act is free of charge for all applicants.

You must transfer the fee within three weeks after the date on top of this form (filled in by the Netherlands embassy or consulate). Your application will only be assessed when the whole amount has been received by the IND. Please check whether your bank deducts a fee from the amount being transferred.

If the assessment of your application shows that you do not qualify for a residence permit in the Netherlands, you will not receive a refund.

7 Declaration of consent

The IND will assess and decide on your application. If you wish communication with the IND to take place by e-mail (instead of by post), you must consent to this first.

8 What will happen with your application?

After receipt of your application, your documents and fee, the IND will assess your application. You will be contacted by the IND if your payment or your documents are not received. You will also be informed once the assessment of your application has been finalised. If your application is granted, you will also receive information about the follow-up procedure.

9 MVV and residence permit

In case your application is granted you will receive an MVV (entry visa) from the Dutch embassy/consulate. When your application is granted you can make an appointment to collect your MVV via www.netherlandsworldwide.nl. The IND aims to have your residence permit ready within a few weeks following your arrival in the Netherlands. The IND will send you a letter indicating when you can collect your residence permit. For this, you have to make an appointment online at the IND desk stated in the letter.

10 Registering in the Netherlands

You need your birth certificate (legalised and translated if necessary, please check www.ind.nl) for registering in the [Personal Records Database \(BRP\)](#) at your local municipality after arriving in the Netherlands. This is a mandatory procedure. When you are registered in the BRP, you will automatically obtain a [citizen service number \(BSN\)](#), unless you already have this.
